# The landlord checklist

From security to safety, our standards are rigorous. As a landlord, you should consider the following:

#### **Gas safety**

Annual gas safety checks are a legal requirement. These checks must be carried out by a gas fitter/engineer who is registered on the Gas Safe Register (which has replaced Corgi). A copy must be given to the tenant before the tenant moves in and the check must have been carried out within the 12 months before the new tenant takes up occupation.

#### **Electrical inspections**

Although not compulsory, the Landlord has a duty of care to ensure all electrical circuits and appliances are safe at the outset of the letting. Therefore it is highly recommended that landlords obtain an Electrical Report and have all appliances PAT tested annually.

#### Energy performance certificates (EPCs)

Before a tenant moves in there must be an Energy Performance Certificate in place for most types of property. A copy of the certificate must be given to any tenant who moves in to the property. From April 2018, any property with a rating of F or below is now unable to be let or any existing tenancy be renewed without improvements being made.

#### Legionella risk assessment

PJC Landlords are required to carry out a legionella risk assessment.

#### Carbon monoxide and alarms

PJC landlords are required to provide smoke alarms in every floor of their property and a carbon monoxide alarm in every room with a solid fuel source.

#### Deposits

If you take a deposit from a tenant under an Assured Shorthold Tenancy, the deposit must be protected under one of the three tenancy deposit schemes within 30 days of receipt. We offer tenants an alternative more affordable NIL DEPOSIT OPTION whilst still fully covering our Landlords with up to six weeks rent at the end of a tenancy.

#### **Rent Smart Wales**

All private landlords are legally required to have registered with Rent Smart Wales. For further information visit www.rentsmart.gov.wales or call 03000 133 344.
